Hi Jennifer,

Thank you for circulating the Ministry of Transportation (MTO) with the attached Zoning By-Law Amendment (Z07-2024) to rezone the subject property to align with the existing use. The submission has been considered in accordance with the *Public Transportation and Highway Improvement Act* and MTO's highway access management guidelines. The following outlines our comments.

The subject site falls within the MTO permit control area, as such, MTO review/permits will be required prior to any onsite work taking place.

MTO does not object to the proposed ZBA. As a condition of the ZBA MTO will require the Highway 21 entrance to be removed and there be no further interconnectivity with the adjacent site to the south. Additionally, the access on Cold Storage Road should be defined to a single point of access (seed and grass along Cold Storage Road from Highway 21 to the entrance) and setback 85 metre from Highway 21.

Any expansion or intensification of the site will require MTO review and approvals.
