SUMMARY

This report is provided to meet the Municipal Act requirement of reporting to the public, the remuneration paid to Council and Committee members.

BACKGROUND

Section 284 (1) of *The Municipal Act* requires the Treasurer to provide Council with an itemized statement of remuneration and expenses paid in the previous year to each member of Council and each person appointed by the municipality to serve as a member of or an appointee to a committee.

Section 284 (3) of *The Municipal Act* requires any body, including a local board, that pays remuneration or expenses to one of its members who was appointed by a municipality, the body shall provide the information to the Treasurer to be included in the public record.

Section 284 (4) states: "Despite the Municipal *Freedom of Information and Protection of Privacy Act,* statements provided under subsection (1) and (3) are public records."

Council and the Committees for Lambton Shores were paid according to By-law #23-11 and this report will detail the remuneration for 2021. The table at the end of this report provides a detailed listing of payments made for both section 284 (1) and (3).
