

**THE CORPORATION OF THE MUNICIPALITY OF LAMBTON SHORES**

**BY-LAW 85 OF 2023**

**BEING A BY-LAW TO ASSUME A HIGHWAY AND INFRASTRUCTURE  
(PORTIONS OF PHIBBS ST AND HENNESSY ST AND LENEVE ST, FOREST)**

**WHEREAS** those portions of streets known as Phibbs Street and Hennessy Street within the bounds of Plan 25M-85 were dedicated to the Corporation of the Municipality of Lambton Shores as part of the public highway system;

**AND WHEREAS** Leneve Street within the bounds of Plan 25M-79 was dedicated to the Corporation of the Municipality of Lambton Shores as part of the public highway system;

**AND WHEREAS** the Council of the Corporation of the Municipality of Lambton Shores deems it expedient that the acceptance and assumption of said lands and the infrastructure contained therein be confirmed by a by-law of the Corporation;

**THEREFORE** the Council of the Corporation of the Municipality of Lambton Shores enacts as follows:

1. That the portion of the public highway identified as PHIBBS STREET within the bounds of Plan 25M-85, the portion of the public highway identified as HENNESSY STREET within the bounds of Plan 25M-85, and LENEVE STREET within Plan 25M-79, all in the Municipality of Lambton Shores, and the works contained therein, are hereby accepted and assumed by the Council of the Corporation of the Municipality of Lambton Shores.
2. This By-law shall come into force and effect upon being finally passed.

**READ A FIRST, SECOND, AND THIRD TIME AND FINALLY PASSED** this 19<sup>th</sup> day of December, 2023.

## BY-LAW 85 OF 2023

### Explanatory Note

Streets and works constructed within those portions of streets known as Phibbs Street and Hennessy Street within the bounds of Plan 25M-85 were deemed substantially complete on November 19, 2021. All outstanding works have since been completed. The minimum required maintenance period has ended and all subdivision works have been deemed to be in good working order and free of defects. The Municipality is therefore formally assuming the streets and infrastructure by by-law.

Further, although By-law 14 of 2023 was passed by the Council of the Municipality of Lambton Shores on February 21, 2023 for the purpose of assuming the streets and infrastructure contained within Plan 25M-79, section 1 of said by-law omitted mention of Leneve Street. This by-law corrects that omission.

The lands affected by this by-law are identified on the key map.
