> We are a non-profit community organization. We have been in operation over 40 years. We provide our community with a newsletter, social media information, community website and community events. We support our environment with weekly beach and community cleanup, removal of invasive species. We hold virtual meetings on conservation and history of Ipperwash. We are an organization formed to help provide a collective voice in addressing concerns of our community. We are open. to property owners and offer associate membership to those who are not eligible for full membership. Our geographical area is West of Army Camp Road, north of Highway 21, east of West Ipperwash Road, south of the Lake Huron Shoreline.

Installation and maintenance of signage welcoming visitors to Ipperwash. Installation of flags and poles throughout the community to celebrate Canada and special days/events. Purchase of benches and garbage receptacles distributed at all three access roads to Ipperwash. Promotion of Ipperwash as a great community through events such as the purchase of equipment used for weekly cleanup of area roads and beaches from May to October, Trash 2 Treasure Day in June, Canada Day Walk in July and, Last Sunset of Summer in August/September. We have approximately 80-100 volunteers of all skill levels and backgrounds who volunteer on a regular basis.

## 2. Project Description

2.1 Provide a description of the proposed project, including the location where the project will take place.

We plan to construct and maintain five planters for beautification of the Ipperwash community as outlined on the Ipperwash Design Plan (2015). They will be portable when installed, and CICA will arrange for storage over the winter months. Installation will beautify each intersection. They will be placed with one on Army Camp Road at East Parkway Drive, two on Ipperwash Road at East and West Parkway Drive, and two on West Ipperwash Road at Arbor Acres and the corner of West Parkway Drive.

Funds are being requested for soil, plants, materials to build planters.
2.2 Describe, in detail, who will benefit from the project. What is the target population that your project will support? How will you ensure that your project is open and accessible to all members of the general public?

All visitors and residents of Ipperwash will benefit from this beautification project. All planters will be readily visible to anyone travelling by foot, car of bike along any of our roadways.

The Ipperwash Design Plan (2015) clearly identified the need and location for these planters.

We are the only organization in Ipperwash. Our volunteers are committed to enhancing the beauty of our community.

No approvals are necessary. Planters will be placed without obstructing existing walkways and roadways. Visibility at corners will be taken into consideration.

Volunteers will set up and take down the planters at the beginning and end of the season. CICA will pay for the yearly plantings. No Municipal staff will be required.

We are new to the area ( 3 yrs ) from 30 yrs in Port Perry because our daughter married a local farmer and our son needs to be established near her before we die. It was so hard to leave our son's supports \& programs, but we needed to think of his future.
We've found out in the Forest there once was a day program offered by LCDS \& another by Dashwood. Post-Covid parents are hopeless trying to find something meaningful days for their adult disabled children. That's why God helped us/told us to start the Forest Fritter Friends.

For thirty years I've found meaningful days for our son. So yes, I've had 30 years supporting him by starting a special needs bowling group \& a special olympics golf program in our town to serve the needs of others.

In September 2023 the "Forest Fritter Friends" Training Center for adults with disabilities was opened.

The PURPOSE of the FRITTER
To give adults with disabilities meaningful interactive days with team members \& with our community. We want to show that our "Team Members" are able workers and we are an important part of Forest. We want our "Team Members" to be seen \& included in all aspects of our town. Not hidden away with aging parents. We currently have team members from Port Franks \& Forest. Our next training session will have team members from Kettle Point, Forest \& Arkona.

The PROJECT is to provide a quality Program to support those less fortunate \& unseen in our Community

Our "Team Members" have committed to volunteer for a six-month training program to give them the tools \& training to hopefully lead to meaningful employment in our community.
This is free to them.
Our Modules -
1- Being Part of the Best Team - Teamwork Modules
2- Producing the Best Products - Product Modules
3- Giving the Best Customer Service - Customer Service Modules
4- Being the Best You - Personal Wellness Modules
We are located at 28 King Street West in Forest beside the Kineto in an aging building.
2.2 Describe, in detail, who will benefit from the project. What is the target population that your project will support? How will you ensure that your project is open and accessible to all members of the general public?

As seen in Forest, those who cannot speak up for themselves live alone and are often seen meaninglessly walking the streets. Our target group are those between the ages of $21 \& 65$ who are sitting at home with their parents or barely serving on the Ontario Disabilities Support Program monthly payment.

Life for an adult with a disability is grim after school finishes. There are no work or day programs available for them and that's what we found for our son Mark. Mark is 30 with autism \& lives with us. We try to keep him engaged \& busy, but we're not enough. He needs more.

We will be serving the needs of the disabled in our community as well as being a destination for shoppers \& tourists in our area. We have been in the media \& have a great response. Guests have come from Kitchener, Wallaceburg, Exeter to see what we are doing \& how we are meeting a need in our community. I'm speaking to parents who need hope.

We love Forest \& have found from other parents that the programs that were available pre-covid have not re-opened. Dashwood \& the the LCDS/Alhambra Centre once offered day programs for groups, but do not now. Parents are desperate for meaningful days for their children and it's going to get worse. Parents need something for their loved ones to do \& somewhere for them to live once we die. This is not unique to our area. We wanted to be part of the solution \& not part of the problem, so God gave us Studio 45 \& we're stepping out in faith building this Training Centre to serve Lambton for years to come.

As well, we are part of the Forest BIA \& have become a destination location for so many from far \& wide. Please come read our guest book or stand in our store to see where our guests are coming from.

I'm sorry, we have applied twice to the Forest Community Foundation and not received any funding or an explanation of why we do not receive funding. As well a Sunset \& Libro.

I have volunteered with the Kiwanis since moving to Forest three years ago. I volunteer as their web designer, tech support \& ticketing operations. My son volunteers at the Kineto three times a week cleaning, collecting garbage \& sanitizing all the arms in the theatre. As a member of the Kiwanis \& the parent who has started the Forest Fritter Friends not-for-profit, I was really hurt when the Kiwanis received $\$ 2,500$ to maintain the train that we use in 2 parades per year.
The Fritter has not received anything, but a train gets $\$ 2,500$. That really crushed my spirit.

I wanted to mention why it＇s the Forest Fritter Friends．We LOVE the great apple history of Forest．We once had the cannery，the basket factory，an apple cider vinegar factory \＆numerous apple orchards that once sent apples over to the soldiers during WW1．

We have an amazing apple history in Forest \＆we are using apple cider from Forest Hill，apples from Sunrise \＆Sparking apple cider from Twin Pines．Our eggs \＆flour come from our local area as well．

Currently，we all volunteer at the Fritter－the Team Members（the adults with the disabilities）and the Coaches（the folks who come support the Team Members）．No one is paid．All our income goes to supporting the program．

It is our hope that once we pay off our debt that we will be able to hire a Program Manager \＆a Product Manager and that the Fritter will continue on for years \＆years because the need will never go away．And that we can transform other empty buildings in downtown Forest into other Training Centres（I have a dream of the opening the＂Royal－Tea on King＂tea／coffee／games cafe to serve the needs of those who used to support the Huron Cove．．．just need more money \＆time）．

We are still very new to this and seeking other forms for funding.
As well, we bought in June 2022 and had such a hard time sourcing reliable suppliers \& renovation workers; that it took us over 14 months to open. I have only supplied quotes from suppliers we trust and that will deliver the product.

When I think of the word vibrancy, I think of alive \& thriving.
The disabled have no voice of their own to speak up for their needs, they rely on others like family \& their community to help them. Parents of adult children with disabilities feel alone and helpless as we seek to care for our loved ones. Helping the Fritter thrive in Forest will not only speak loudly to the disabled community, but also to the world. Forest would be known as the town that is inclusive to all abilities.

The needs of the disabled will not go away. We can help them by giving them the skills to help them find jobs. And this helps everyone in the community \& the future success of those less fortunate.

Our club has supported and completed several projects over the years. 2006 saw a new roof and toilets installed. 2008 had the lighting towers painted and metal halide lights installed. 2012 and 2014 had the green backboards replaced.

We are well situated however to move forward with new projects. We have recently been awarded funding from the Forest Community Foundation to replace windows and a door in our clubhouse.

Gerry Sanderson has a strong mechanical background and currently maintains our equipment and clubhouse.

Brian Blair is a Project Management Professional with many years of running capital projects in the nuclear industry which included financial,engineering, installation,scope control and post project lessons learned.

John Minielly has provided budget and financial support for our club for many years.

## 2. Project Description

2.1 Provide a description of the proposed project, including the location where the project will take place.

The project will take place at the Forest Lawn Bowling Club which is located at 6276 Townsend Line Forest Ontario.

The project is to refurbish the existing lawn watering system. This will include a replacement of the water timer station, installation of underground piping and installation of 25 sprinkler heads.
2.2 Describe, in detail, who will benefit from the project. What is the target population that your project will support? How will you ensure that your project is open and accessible to all members of the general public?

The goal is to enhance the current membership experience while participating in lawn bowling activities. Also attracting new members to the club to fully utilize our facility and provide an engaging experience for the new bowlers.

Our primary population of members are Senior Citizens. We are attempting to procure lawn bowls that are sized for youth. With these bowls we will be able to attract younger members to our game.

We are always open to the public to join or come out and try our sport. We offer 2 free trials to people interested. We run community events to garner interest and prospective members.

We attend the Welcome to Forest event to attract newcomers.
2.3 Describe the need for the project, including identifying any gaps that exist. List any documented studies or reports that support the need for the project.

The current irrigation system was installed in the 1970's and has aged over this time. The current sprinkler head location does not adequately cover the green area. Some location are over watered or under watered or not at all. The piping configuration in the maintenance shed is not configured properly to assist with fall blow outs of the sprinkler heads. The existing timer is aged and modern timers have preferential options that allow for maximizing watering cycles.

Live Green Irrigation have performed a site visit during winter blow downs and advised on necessary improvements. Live Green Irrigation is a leading irrigation installation and maintenance company located in Forest.

We will also be contacting the Municipality of Lambton Shores to advise them of the work being done.

The project is essentially a one time project other than occasional maintenance on sprinkler heads. Seasonal turn on and fall blow downs are performed by our club.

This project is for a portable Indigenous Spirit Animal and Story Booth (ISA\&SB). It is a selfcontained full equipped project that can be used at events such as Paint Ontario, Canada Day celebrations, at local schools and other festivals.
In the new venue for Paint Ontario, we will add this booth as a new leature. It will be added to the transportable walls, plinths, lighting and art racks.
We have signed a lease with the Grand Bend Legion Branch 498 for the PO Event for 5 years. A storage container will be required to house the spacious 20 foot wide canopy tent and the Paint Ontario production equipment, which will be accessible for use by the Grand Bend Art Centre and various community groups including Rotary and Optimisis.

The funds will allow for the purchase a safe and accessible storage unit for the ISA\&SB as well as to store Paint Ontario production items.
Other organizations will be able to borrow the equipment and we can ensure that they will be properly maintained and cared for to last for the anticipated 10 years.
When a new community centre is open, the production equipment will be easily transferred.

The chip and dust renewal at both the walking track and the Circle of Life path will improve the quality of the surface for safer, better movement.
