Area Affected by Licence

1. This licence applies to a portion of the property located at 8529 Townsend Line, all loss, cost, expense, judgment or deman,"A" pseudo isos, seol lis

Municipality, its servants, agents, or employees related to or arsing (mia)

2. This Agreement commences on February 6, 2024 and expires on May 14, 2026, with an option to renew for an additional five years.

License Fee

The Municipality shall pay to the Owners the sum of THREE HUNDRED DOLLARS. (\$300.00) annually for the use of the parking area, payable in July of each year.

Termination with Notice

4. The license agreement may be terminated by either the Municipality or the Owner, by providing a minimum of 30 days' written notice.

General

- 5. The Municipality shall maintain the parking area; however it is acknowledged that winter maintenance will not be performed on the property.
- 6. No overnight parking will be permitted in the parking area.
- 7. Storage will not be permitted on the property, other than the storing of snow by the Municipality or its contractors during the winter months.

Risk

- 8. The Municipality agrees to assume all risk and liabilities associated with use of the parking area and will:
 - a) Carry liability insurance in an amount not less than \$2 million dollars which includes the Owners as an additional insured, and will provide a copy of the policy to the Municipality at the time of the signing of the agreement.

Indemnity

- 9. The Owners agree to defend, indemnify and save the Municipality harmless from all loss, cost, expense, judgment or damage on account of injury to persons including death or damage to property, in any way caused by the negligence of the Owners, its servants, agents or employees related to or arising out of programs or other matters to which this agreement pertains, together with all legal expenses and costs incurred by the Municipality in defending any legal action pertaining to the above.
