The Arkona Lions Club was founded by volunteers in 1948 to enhance and strenthen our community. We strive to improve the lives of our neighbours with local project stewardship, public events and humanitarian contributions. Through the Arkona Medical centre our objective is to ensure timely access to quality medical and dental services for Arkona and area residents. Our mandate is to provide a clean, professional and ergonomic environment for staff and patients.

	In 1967 we recognized the need for a dedicated medical facility to attract general practitioners. The 2000 square foot clinic was completed in 1969. In 1985 we added a 1500 square foot wing to offer dental care. We continue to maintain and manage the building as a non profit health centre.
	In 1972 we built the Arkona Lions Museum to celebrate the natural and pre-colonial history of the area. We improve the building and update the displays on a regular basis to keep the facility current.
	In 1987 we built the Orchard View appartment complex with 25 geared to income rental units. We manage and maintain the building on a non profit basis to provide affordable housing for seniors.

	Phase 3 of the Arkona Medical Centre will be attached to the east end of the existing structure at 14 Union Street east in Arkona. The addition will add 1200 square feet to the dental wing and update the existing interior.

	Dental patients will benefit from reduced wait times for appointments and the addition of dental sevices. Dental surgery including overnight accommodation for children will be added. A denturist will also be brought on staff. Medical patients will benefit from an expanded dental operation that subsidizes the medical practice. Medical and dental proffessionals rent their space from the Lion's Club and the majority of rental income comes from the dentists. The last two medical contracts have included free rent for the first two years. All revenue from rent reciepts is re-invested in the medical centre. The dentists and physicians are both seeking new patients. Our goal is to accept everyone that applies.

	The current wait time for a non urgent dental appointment is approximately 7 weeks. This is almost double the Ontario average. Patients requiring surgery or dentures now have to travel to a larger centre.

# 3. Financial

3.1	Describe what the requested funds are being used for. <b>Note</b> that if approved, funds cannot be used for anything other than the stated purposes.
	Vibrancy funds will help cover construction costs for the addition. The total budget for this project is \$607,288.00+HST. The dental practice is covering \$162,529.00 of that total leaving \$444,759.00 to be paid by the Lions Club. We are requesting one third of our portion or \$148,253.00.
3.2	Describe the fundraising strategy and other funds that have been secured to support this project. List any funding partners.
	The Arkona Lions Club raises money through charity bingos and monthly meat draws. We also hold two major fundraisers per year. A community campaign was launched in June 2023 to solicit individual and corporate donations. We are one of five clubs in Lions zone six. This year all proceeds from our annual zone project(approx. \$10,000) will go towords the Arkona medical centre addition. The Arkona Community Foundation has pledged \$50,000. The outstanding balance will have to be borrowed from Libro.
3.3	Describe why Vibrancy Funds are needed for this project.
	Vibrancy funds will reduce the amount we need to borrow for this project. The stability and viability of the medical centre depends on the support of our municipality.

#### 5. Required Documentation

**Project budget:** A project budget must be submitted with the application.

**Lease or proof of ownership:** Proof of ownership is required for capital projects that involve renovations, repairs or retrofits to buildings, parks, or facilities. If the applicant is not the owner, the owner must provide a letter of agreement for the project, and their proof of ownership.

**Community support:** At least one letter of support from a local organization is required.

**Business case:** Include with the application a detailed business case outlining how the project will be managed, sustained, and operated over the long term. Provide information related to how the project aligns with one or more of Council's Strategic Priorities. The applicant is required to present the business case to Council once staff have determined the eligibility of the project.

#### **Phase 3 Business Case**

#### The Project

- -Our dental practice has outgrown their current space.
- -The Canadian Dental Care Plan will significantly increase the number of dental patients.
- -Phase 3 will add 1200 square feet to the dental wing.

#### The History

- -The Arkona Medical Centre was founded in 1969 to provide a dedicated clinic for general practitioners.
- -In 1985 we added a 1500 square foot dental wing.

#### Long Term Management

- -The Arkona Lions Medical/Dental Board maintains the building and administers lease agreements with doctors and dentists.
- -The monthly rent for the dental wing will increase from \$2500 to \$5000 upon completion of the addition.
- -Dr. Jeremy McCallum has committed to a 20 year lease with terms reviewed every 5 years.

## Strategic Alignment

- -The expansion will facilitate additional dental staff including a denturist and an oral surgeon.
- -Seniors, youth and lower income patients will benefit from the CDCP coverage and our increased capacity.

#### Arkona Medical Centre Phase 3 Expansion

#### Project Budget

We have agreed on a final price of \$450,000 including HST. Construction is scheduled to start March  $18^{\rm th}$  and be completed in 90 days.

#### **Business Case**

The Arkona Lions Medical Board has managed the health centre since 1969. We have a 5 year commitment from Dr. Farzadfarr, our current medical staff, which expires in October 2028. We expect she will renew her contract and hope to have her with us for many years. Dr. McCallum, our resident dentist has committed to a 20 year contract with lease terms reviewed every 5 years. With help from the Vibrancy Fund this project will have a profoundly positive impact on the health of our community.


